We build websites to our good faith understanding of WCAG 2.2 AA and test all website HTML with WAVE and/or Axe automated tools during development and before delivery. Accessibility-as-a-Service (AaaS) websites will receive additional manual review before delivery. The level of conformity of the final site will depend in part on the content, images, media, documents, etc. provided by the client (e.g. captions and descriptions for

various media) and will also be dependent upon the AaaS tier level chosen. Client-requested modifications that affect accessibility compliance will be brought to the client's attention.

In instances where the client would be required to provide content such as accessible media files, PDFs, alternate text, etc., we have indicated "Supports" and listed the content needed in the Remarks and Explanations field.
